Annual Treasure Sale Scheduled for June 29

It is once again time for spring cleaning! Your unwanted items can help raise money for Edgewater's Rec and Social Committee annual Treasure Sale. The sale will be on Saturday, June 29th and is the biggest fundraiser of the year.

It is easy to contribute and Committee members will be accepting donations in the Pool Building the week leading up to the

sale. You can donate just about anything - toys, antiques, collectibles, books CDs, DVDs, clothing, and more. Money raised will be used for social activities at Edgewater as well as special projects. Projects being considered include:

- Replacement of deteriorated picnic tables
- Replace heavy tables in the Lakeside Lounge with lightweight tables like those in the Pool Building
- ♦ Canopy to provide a shaded area by the pool
- Replace worn lounge chairs in the pool area with better quality chars

Rules & Regulations ...

- Owners and/or occupants are permitted to park one vehicle in resident parking areas. All
 other vehicles must be parked in the visitor and guest parking area.
- All vehicles registered as commercial or with commercial advertising or lettering must be parked in visitors and guest parking areas.
- Tractors, trailers and large trucks must park in board designated parking area.
- Only vehicles with a state or municipality issued handicapped parking sticker/tag may
 park in areas marked for handicapped parking. Violators are subject to the laws of the
 State of New York and may be issued a citation by law enforcement and/or have their
 vehicle towed at the owner's expense.
- All owners and occupants are required to have a parking sticker or tag on their vehicle at all times. Stickers are to be placed on the left rear side window of the vehicle. Guest tags may not be used for more than 30 days.
- If a vehicle is left running unattended, exhaust fumes must not be directed toward the buildings.
- Each unit will be allowed a total of three vehicles on Edgewater property. "Vehicles" include cars, trucks, boats, and all other recreational vehicles. Residents desiring to have additional vehicles will be charged an annual fee as follows:

Vehicle 4: \$250, Vehicle 5: \$400, All additional: \$500 per vehicle

Any extra vehicles (more than three) must be parked in an area designated by Edgewater Administration. All vehicles must be registered and insured. All RVs and motor homes, must be stored or parked in the designated parking area on the west road.

Driving on Edgewater Roadways

Unlicensed drivers are not allowed to operate vehicles on the premises.

Speed limits are as follows: Entrance Road: 15 mph, Interior Roads: 10 mph, Exit Road: 20 mph
