Keys, Keys, Keys ...

We feel it is important to bring up the section of the Rules and Regulations regarding keys. Recently we found out that some of the keys are missing or outdated. Representatives from the Board will be going door to door to test the keys in the very near future and letters will be sent to those in non-compliance. If we need to gain entry, for whatever reason, and your key is missing or does not work, any damage that occurs in gaining entry is the homeowner's responsibility. Page 10 from the Rules and Regulations follows:

Locks and Passkey

The Board of Managers MUST retain a passkey to the premises. Owners who install new exterior locks must insure a new key or passcode is provided to the Office.

New Procedures for Unit Rentals ...

The Edgewater office will no longer be "loaning" out keys to renters. If you deal through a rental agency it is your responsibility to supply the agency with a key to your unit. The rental agency will then fill out all necessary paperwork and return it to the office.

If you deal directly with either long-term or short-term renters, paperwork will be available in the office. Short-term renters will be issued a temporary parking pass to be displayed from the inside mirror.

A pool rules agreement must also be signed by the renter prior to using the pool. This is imperative so PLEASE do not give out your pool key. Unknown persons in the pool will be asked to leave if they have not signed the rules agreement.

The following is the section regarding rentals and leasing, taken directly from the Rules and Regulations.

Leasing of Units

All owners who rent to a tenant shall:


- Provide the tenant with a copy of the Rules and Regulations.
- Include in the lease agreement a provision that the tenant has been given said copies, has read and understood, and agrees to abide by these documents.
- Notify the Board of Managers in writing that the unit is tenant-occupied, giving the name(s), address and phone number of the occupants.
- Provide to the Board the name of any agent retained by the unit owner to manage the unit for him/her. The unit owner is responsible at all times for the enforcement of the established guidelines.
- No condominium unit shall be rented for transient or hotel purposes.

Laundry Facilities to be Updated ...

Both laundry facilities are slated for a total overhaul this month. The Board of Managers has contracted with national corporation Mac-Gray to lease new equipment, retiring all the old, worn equipment we now own.

This will provide for new equipment, including some high-capacity washers, and will work on an electronic card. Quarters will no longer be necessary.

Details and an informational open house will be scheduled once the new equipment is here.
