From the Treasurer ...

Before I begin with the financial information, I wish all the residents and employees of Edgewater Condominium a safe, healthy and happy holiday.

For the ten months ended October 31, 2014, we have a balance of \$48,083.43 in our checking account and a balance of \$122,028.43 in our reserve account. Our net income year to date is \$56,364.94 compared to a budgeted net income of \$54,050.88.

I am very pleased to report that as of October 31, 2014 we have only **2** homeowners who are greater than 90 days delinquent in their maintenance fees for a total of \$29,528.00. Of this amount, one unit owner that is currently in foreclosure owes \$26,365.27. This property should soon be reported in the Westfield Republican for sale and once this is done for 4 weeks we can then proceed with a sheriff sale of this property. Hopefully this will be completed early in 2015. I will keep you apprise of the status of this foreclosure in future newsletters.

The budget meeting was held on December 3, 2014 to present the 2015 budget. We have two budgets this year; one is our operating budget and the other is a common expense/capital project budget. I will be consulting with our accounting firm for their recommendations on the future format of these budgets.

Since there was no attendance at this meeting and understandable so; the board has decided to hold the budget meeting at the same time as our annual meeting in June each year going forward. This meeting seems to have better attendance since the snowbirds have returned to Edgewater and by far, the weather is more cooperative.
