For the eleven months ended November 30, 2015 our net income year to date is \$116,243.87 compared to a budgeted net income of \$74,890.00. We have cash in the bank in the amount of \$309,779.95 as of November 30, 2015. This includes both our checking and reserve fund.

We still have two homeowners who owe special assessments totaling \$1,060. As I have said in previous months, we have filed liens against these homeowners and continue to speak to them about the necessity of making these payment obligations.
