Highlights of the November 25th Board of Managers Meeting

- J Building Deck. 2 Bid proposals have been received and are being reviewed for this project. The cost is slightly more than the previous K Deck replacement, due to differences in the concrete structure of the J Deck.
- Water Shut-Off Value Replacement Project. We are waiting for 2 proposals to excavate and replace the values, which will in turn be given to the Town of Westfield for approval.
- Winter Plowing. The Board has approved the annual plowing contract with Westfield Nursery.
- Waste Removal. The Board approved the retention of Bestway Container Services for our waste removal in 2018.
- **Edgewater Website**. Rick will be redesigning the Edgewater website for 2018. One upgrade he is looking into is a Resident's Forum.
- Tax Assessment Case. There is a meeting scheduled on November 27th with all parties and attorneys to discuss progress
 and resolution of this issue. The Board decided to contact our attorney with a request for an immediate update on this
 meeting, as well as his attendance at our December Board of Managers Meeting.
- Final Pet Policy Approval. The Board voted by a 3-2 margin to adopt the new Pet Policy as written. This Policy will go into effect on January 1, 2018. The Board also reviewed the new Pet Registration Form, which is a part of this Policy.
- 2018 Budget. The Board voted unanimously to approve the 2018 Budget as presented.
- Recent Flooding. The erosion of the area near the culvert on the P building roadway as a result of the recent November rainfall was discussed. We will be looking into placing rip rap around the areas there that are prone to flood erosion as a preventative measure.

We had another profitable month in October 2017. During the month of October we had earned income of \$7,751.96 making our accumulated net income \$10,475.55 for the ten months ended October 31, 2017.

Our cash assets include the following: reserve account in the amount of \$40,558.89, checking account in the amount of \$67,257.68.

Our delinquencies over 31 days totals \$2,349.98 while our total account receivables totals \$4,447.57. We have one delinquency that may be subject to a lien filing. We will be contacting them once again to attempt collection and avoid filing a lien.

The Board approved the 2018 budget and you will be receiving it in December, 2017.
