President's Notes

A proposed amendment to ARTICLE XIII, Section 8: CHARGES, ASSESSMENTS AND PROFITS of the Declaration of Edgewater Condominium By-Laws, was mailed to all owners on July 2nd, 2018. The purpose of the amendment is to establish a Capital Contribution Fund (CCF hereinafter) to be funded by new buyers, deposited in a special account, and used to defray the cost of unanticipated capital improvements (such as deck failures) in an effort to alleviate special assessments to all owners that may become necessary in the future.

Enclosed with the proposed amendment was the opportunity to approve via postcard and an invitation for review, discussion and count for approval to be held following the regular Board of Manager's meeting on July 28th.

The approval process of the Amendment was tabled at the special meeting held immediately after the regular Board of Managers meeting on July 28th until language of the proposal could be clarified and further discussion with owners could take place. All postcards returned from owners at that time are null and void.

On August 5th, the Board mailed an invitation to all owners to attend a special hearing about the CCF on August 27th, along with a red-lined version of the original proposed amendment to highlight alternative language proposed by the Board.

The special hearing about the proposed amendment was held in the Lakeside Lounge on Monday, August 27 at 6:00PM. Approximately 18 residents and the full Board of Managers were in attendance. The meeting was not adjourned until all comments were heard and questions were answered.

For those of you not in attendance at any of the meetings, or still not clear about what the CCF is all about, a brief summary is found on page 2 of the ECA Community News Volume 18, Issue 8, August 2018. All minutes from board meetings and past newsletters are found at the Edgewater Website at www.edgewatercondos.net in the Residents' Portal. If you are an owner and do not have a password for the portal, please contact the office.

Once the Board and legal counsel have approved the final language of the Amendment, there will be another mailing to all owners with a copy of the final version, the opportunity to approve, and instructions about how to make your approval count. Please follow those instructions carefully.
