July 2019 Meeting Highlights

The Board of Managers were extremely pleased to have 35 homeowners in attendance at the August 2019 board meeting. Many homeowners spoke out with concerns regarding various emails and letters that were mailed out about the upcoming special election.

The association manager, Rick Clawson, received the Deck/Railing Inspection Report immediately before the meeting, noting that the N Building roadside deck is in very poor condition and needs to be replaced in 2020, and most, if not all railings need to be tightened or replaced. He explained that the contractor for drainage, at J Building, will be returning to install 2 more drains prior to Westfield Nursery grading the lawn to finish the project. Unit 504 has a water leak and two contractors plan to give an estimate to repair it. Rick reminded all present that all storage units must be emptied by September 30th, 2019. Proposals to repair the entrance to the Lakeside Lounge building and to repoint and repair the northwest corner of the of the exercise room were reviewed by the board and voted upon.

Board members, Lee Davies and Janet Greene, presented a report on the Special Election/Nominations Committee Report. They explained that every aspect of the nominations presented by the committee were made in accordance with the Bylaws of the Association, quoting sections of those laws, and pointing out that a letter mailed to some homeowners, stating otherwise, was in error. The nomination committee will mail out a letter to ALL HOMEOWNERS, explaining the procedure that has been and will continue to be followed in accordance with our Bylaws.

Following a motion and second, the board voted to approve acquiring a separate special mail box for all election ballots to be mailed.
