# Administrator's Report - Rick Clawson

- Delinquency Update Certified letters have been sent to three individuals.

  Attorney Mark Bargar sent a letter to the number one unit owner in arrears, notifying the owner that foreclosure proceedings will begin February 1.
- Association Liability Insurance Reported that we are working with both Mayville-Tremaine Agency and Allstate Insurance to obtain new competitive offers for Association insurance.
- Building & Grounds Inspection Report Nothing new to report at this time.
- Apartment kitchen renovation Reported that the kitchen renovation is nearing completion.
- Lounge/Exercise room painting projects The lounge has been completely repainted, as well as the laundry room. The floor in the exercise room has been repainted, and new carpeting has replaced the old moldy carpet.
- Sidewalk/stairway snow removal The maintenance crew has been instructed to use ice melt regularly on the walks, stairs and balconies to insure the

safety of residents. Rick has ordered a broadcast spreader to make it easier to distribute ice melt evenly on the walkways.
