Administrator's Report - Rick Clawson

- WWTP Update Hill Engineering The study has commenced and Tim Wells and Andrew Thompson will be surveying the facilities on Tuesday, October 22.
- Insurance update- Reinhardt Agency has submitted a proposal which was received too late to present to the Board at this time. The final proposals will be presented to the board at the final budget meeting.
- Foreclosure update The foreclosure is still on track, however there is no final date at this time when it will be completed,
- Chimney Inspections reported that the company that formerly did chimney inspections is no longer in business. One proposal has been received and there will be an increase from \$30/\$60 (in the past) to \$80 for an inspection and \$140 for cleaning. Letters will be sent out to those owners with fireplaces notifying them of the increase, as well as the date for the inspections. Waivers may be submitted to those who no longer use their fireplace.

 Deck restoration - Masonry & More was scheduled to work on F deck, but weather did not cooperate. Rick reported that the possibility remains to complete the deck, but poor weather is approaching quickly. It was also reported that both N and P building have cracks on walls that need repair. We are waiting for word from the contractor on pricing.
